

2013 Cross Compliance Statistics

The tables below provide a breakdown of the non-compliances (breaches) found during cross compliance related inspections in 2013.

Table 1 shows the number and level of separate breaches found under each Statutory Management Requirement (SMR) and Good Agricultural and Environmental Condition (GAEC).

Table 2 shows the number and level of reductions applied to farmers' claims once the various capping and repetition rules have been applied.

There is a difference between the Totals in the two tables because a small number of farmers were found to have breached more than one requirement.

Cross compliance related payment reductions are applied to the following support scheme payments - Single Farm Payment Scheme (SFPS), Less Favoured Area Support Scheme (LFASS), Scottish Beef Scheme (SBS) and certain Rural Priorities (RP) and Land Manager's Options (LMO) scheme payments.

The current total value of cross compliance penalties applied to the **Single Farm Payment Scheme, Less Favoured Area Support Scheme and Scottish Beef Scheme** in 2013 is £581,582*.

The current total value of the **Single Farm Payment Scheme, Less Favoured Area Support Scheme and Scottish Beef Scheme** in 2013 is £534,602,974*.
